




TERMS AND CONDITIONS

- 1 The details of bid documents schedule and set of term & conditions is available in NAC office, Khandapada and office website <http://www.khandapadanac.in> and District Website www.nayagarh.nic.in on payment of **₹2,000.00 (Rupees:- Two thousand)** Only (Non-refundable) towards cost of tender/ Eol documents in shape of DD/ Banker cheque drawn on any Nationalized Bank in favour of Executive Officer, Khandapada NAC payable at Khandapada. Quotation without payment of paper cost shall not be accepted in any case and will be rejected similarly.
- 2 The bidder must be accompanied by EMD/ tender security amount of **₹5,000.00 (Rupees:- Five Thousand)** Only in shape of DD/ Banker cheque/ Fixed Deposit drawn on any Nationalized Bank in favour of Executive Officer, Khandapada NAC payable at Khandapada. Quotation without EMD shall not be accepted in any case and will be rejected similarly.
- 3 The sale of tender/ Eol documents start from **dt.06.01.2024 at 10.00A.M to dt. 16.01.2024 up to 5.00P.M** Request for tender/ quotation documents through post will not be entertained.
- 4 The completed & sealed Eol and other documents will be received offline on or before **dt. 16.01.2024 upto 5.00 PM** by the Executive Officer, Khandapada NAC **through registered/ speed post only**. The envelope containing the tender documents should be superscripted with **"Drone Survey with Water Quality Test and Quantification of legacy Waste of Khandapada NAC"** with tender / Eol.
- 5 The tender/ Eol/ bid documents will be opened on **dt. 17.01.2024 at 11.00 AM** in the chamber of Executive Officer, Khandapada NAC in the presence of the bidders or their authorized representatives who wish to attend. If office happens to be closed for any reason on the date the receiving or opening of the tender as specified the tenders will be received/ opened in the next working day at the same time & venue.
- 6 The NAC will not be responsible for postal delay.
- 7 Bidder should submit self attested copies of (i) PAN, (ii) GSTIN (iii) Firm/ Agency/ Surveyers/ architectures certificate alongwith the bid. Quotation without one or more of these documents are bound to be rejected.
- 8 The quotationer should quote single rate for each item according to required specification wherever mentioned. More than one rate for a particular item will be summarily rejected. The schedule appended to the Eol call notice should be filled up and signed.
- 9 The bidder shall quote in item wise as per work described in scope of work and BoQ.
- 10 The quoted rate shall be inclusive of all taxes and duties if any. Taxes and duties shall be mentioned separately if required.
- 11 Any correction or overwriting in the offer should be attested by the quotationer.
- 12 The rate should be mentioned in both figures and words.
- 13 The rate is valid for one calender year.
- 14 The quotationer shall submit the quotation schedule duly signed by him with seal.
- 15 Validity period of bid- 90 calender days from the date of opening the bid
- 16 The Quotationer shall not sublet, transfer or assign any part of the full work of this award without prior written permission from the Executive Office, Khandapada NAC.
- 17 The EMD shall be forfeited on the following grounds :
 - i If the successful bidder fails to executive work in time.
 - ii If the bidder does not change/ rectify any defects found in the work.

- 18 The bidder should have minimum three years experience in the relevant field and the same should be submitted to the undersigned for technical evaluation.
- 19 Bid Submitted through by hand/ courier will not be entertained and will be rejected without assigning any reason thereof.
- 20 Successful bidder should make drone and other surveys of existing dump site in Odagaon Municipality Area.
- 21 Successful bidder should submit the details of longitude, latitude, survey report including quantification of legacy site. along with the 3D map of the existing dump site.
- 22 In case more than one bidder quoted with same lowest price for same item, then the tender accepting authority will finalize the tender through a transparent lottery system in presence of authorized representative of the bidder.
- 23 In case the service delivered is not satisfactory, penalty up to 25% shall be leveled from the bill amount along with EMD will be forfeited.
- 24 Weightage will be given to the bidder who has similar type of experience.
- 25 Payment will be made to the successful bidder after submission of all the documents as per requirement in both hard & soft copy along with bill as per clarification of concerned Nodal Officer
- 26 The authority reserves the right to reject any or all the tenders without assigning any reason thereof.


